IIPT SC Minutes 10/15/19

Approval of revised June and September minutes by Michelle and Karen seconded. Sue will send minutes to Chairs.

Committee Reports:

Stefanie- Candidates: none of the candidates wanted to be a SC rep, so Stefanie will continue in her current role. There was a question around the due dates for the annual drafts and reports in the Spring. The institute date for this year is not yet known. Proposal at this time is First draft due 3/15/19 and Final draft due 4/15/19. All the information needed for the permanent files will be due by 4/22/19. This includes the supervisor/supervisee evaluations. This is so that the CPC can begin their annual review process by 5/6/19. Karen will also need to be cc'd on all candidate reports and evaluations.

There was also a question about the processes that will occur for candidates who do not finish all components of their program in April 2019. Sue and Colleen will determine a structure for individualized programs by 12/30/19. They want input from SA's and Stefanie will gather input from candidates. This will necessitate a change in the handbook. Lea was very happy that all candidates will graduate from the didactic portion of the program, though some candidates will have a blank certificate since they will not have finished the practice portion of the training to be certified to practice independently. Sue and Colleen will meet with each candidate.

Michelle – CCC: schedule for Spring CCC will need to be in place by 11/19. Will need to open CCC leader to one, two, or three IIPT Faculty who are good at teaching this and would share their own case formulations. The committee agreed some structure is necessary for candidates in developing their case formulations, but also that they need freedom to communicate this as it applies to their cases. Recommendation is for a guide, vs a template. Michelle also noted that Doug Dennett is a new member to her committee.

Karen – CPC: Karen has temporarily stepped out of her Chair role on the committee until after the November weekend when she concludes leading the GAM for the Candidate group. The CPC is continuing to review and communicate with three candidates regarding their program status.

Pat: Absent, nothing to report.

Lea – SA's: Nancy chaired for Lea in her absence at the last SA meeting. The main issues discussed were candidate progress/status and the APsaA visit.

November Weekend: Andi will present at the November weekend for the Candidate Conference, which will be held at lunchtime on Friday. The IIPT Plenary will be held on Saturday. Stefani will take this back to the candidates.

APsaA: The visit went well. The evaluation continues and we may have the results in either February or June.

At this point in the meeting, Stefanie and Michelle left the meeting so the committee could discuss the status and progress of two candidates.
